Transfer of Securities to the Euro MTF market

Notice is given that on or about 30 Sept 2023, certain outstanding securities issued by Deutsche Bahn Finance GmbH (see appendix for details) will be transferred from the regulated "Bourse de Luxembourg" (BdL) market of the Luxembourg Stock Exchange to the Euro-MTF market of Luxembourg Stock Exchange.

Motiviation

In 2019, Deutsche Bahn Finance GmbH decided to have its new bond issues listed on the Euro MTF market instead of the BdL market. Since then, over 30 bonds have successfully been listed on the Euro MTF market. By also transferring the above legacy bonds to the Euro MTF market, Deutsche Bahn Finance GmbH can reduce cost and complexity, including eliminating the need for a second auditor in the Group.

The Euro-MTF market

Established in 2005, Euro-MTF market was the first Multilateral Trading Facility in Europe as defined under MiFID. It is regulated by Luxembourg Stock Exchange (LuxSE) and offers a one-stop solution for prospectus approval and admission to trading.

Euro MTF is recognized as an established and efficient marketplace, attracting an array of international issuers. These range from sovereign and sub-sovereign issuers to leading corporate entities and financial institutions. All securities listed on Euro-MTF are admitted to trading on LuxSE.

Differences between the market segments

The Luxembourg Stock Exchange operates both the BdL market and the Euro MTF market. The main difference between these two markets are less stringent disclosure requirements on the Euro-MTF market.



- In particular, the Euro MTF market is outside the scope of the EU Prospectus Regulation and the EU Transparency Directive.
- The LuxSE itself is responsible for the review and approval of a prospectus for an admission to the Euro MTF market pursuant to its Rules and Regulations; whereas for an admission to the BdL market, the relevant competent authority is the CSSF.

Impact for Investors

The bonds of Deutsche Bahn Finance GmbH remain listed on the Luxembourg Stock Exchange. Also the terms & conditions of the bonds remain unaffected. Investor protection provisions from the Market Abuse Regulation (MAR) continue to apply (ad-hoc publicity, etc).
